LOCAL LAW ESTABLISHING A DATE FOR THE MEETINGS  
OF THE BOARD OF ASSESSMENT REVIEW  
CHANGE THE GRIEVANCE DAY FOR ASSESSMENT

A Local Law entitled Local Law No. 1 of the year 2024, entitled "A Local Law to Change the Grievance Day for Assessment.

BE IT ENACTED by the Town Board, Town of Amsterdam as follows:

SECTION 1. PURPOSE

The purpose of this local law is to established a date pursuant to Real Property Tax Law Section 512(1-a) for the meeting of the Board of Assessment Review other than the fourth Tuesday of May, because the Town employs an assessor who is at the same time employed by other assessing units.

SECTION 2 DATE FOR MEETINGS

The Town of Amsterdam established the date for the meetings of the Board of Assessment Review to the second Monday following the fourth Tuesday in May.

SECTION 3 EFFECTIVE DATE

This Local Law shall take effect immediately upon filing in the Office of the Secretary of State.


