NOTICE OF ADOPTION OF RESOLUTION BY TOWN BOARD, TOWN OF AMSTERDAM SUBJECT TO PERMISSIVE REFERENDUM

NOTICE IS HEREBY GIVEN, that a regular meeting held on the 21st day of August 2024, the Town Board of the Town of Amsterdam, New York, (the "Town") duly adopted a resolution, an abstract of which follows, and which resolution is subject to a permissive referendum pursuant to Town Law Article 7: By resolution No. 86 of the Town Board of the Town of Amsterdam desires to appropriate a sum not to exceed \$3,500 to pay the cost of preparing a general map and plan for providing sewer service to the property at 254 Log City Rd., in accordance with the procedures for sewer district extension set forth at Art. 12 Section 191-A of the NYS Town Law

A RESOLUTION TO ACKNOWLEDGE ACCEPT A PETITION TO EXTEND THE TOWN'S SEWER DISTRICT; ALLOCATE FUNDING FOR THE PREPARATION OF A MAP, PLAN, AND REPORT; MAKE CERTAIN DETERMINATIONS WITH RESPECT TO ARTICLE 3 SECTION 24 OF THE NYS MUNICIPAL HOME RULE LAW; AND INITIATE THE SEQR PROCESS

Whereas, the owner of certain real property at 254 Log City Rd (SBL 24.-7-8.3) desires that the Town sewer district be extended to incorporate this property in order that sewer service be provided thereto; and

Whereas, said owner has submitted a petition, as provided for in NYS Town Law Art. 12 Section 191, which is annexed hereto; and

Whereas, a map, plan, and report, meeting the requirements of NYS Town Law Art. 12 (MPR) must be prepared; and

Whereas, the Town's designated engineer, Delaware Engineering, D.P.C., has indicated that the cost to prepare said MPR is \$3,500, the allocation of which to MPR preparation is, under Art. 12 Section 191-A, subject to subject to a referendum on petition, under section twenty-four of the municipal home rule law; and

Whereas, the proposed Town sewer district extension is an action subject to the requirements of the State Environmental Quality Review Act and its implementing regulations (SEQR), and the Board has caused to be prepared part 1 of the short environmental assessment form; and

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. The Town Board hereby accepts the aforesaid petition as having met the requirements of NYS Town Law Art. 12 Section 191.

- 2. With respect to the allocation of funding to prepare said MPR, consistent with Art. 12 Section 191-A:
 - a. The Town Board hereby appropriates a sum not to exceed \$3,500 to pay the cost of preparing a general map and plan for providing sewer service to the proposed extension (i.e., the MPR), and directs its engineer, Delaware Engineering, D.P.C., to prepare said MPR; and
 - b. The Town Board desires to state that the action allocating funds to prepare the MPR authorized in this resolution is subject a referendum on petition, as set forth in the NYS Municipal Home Rule Law, and that, in consequence, the Town Board hereby directs
 - c. that this allocation approval shall not take effect until after forty-five (45) days from the date of this resolution, provided that all of the requirements of Art. 3 Section 24 of the Municipal Home Rule Law are satisfied.
- 3. The Town Board hereby classifies the proposed action, extension of a sewer district to provide sewer service to the subject parcel, as an unlisted action, in accordance with SEQR, and declares itself lead agency for purposes of conducting an uncoordinated SEQR process.
